- 1. uphold the rule of law and the proper administration of justice;
- 2. act with integrity;
- 3. not allow your independence to be compromised;
- 4. act in the best interests of each client;
- 5. provide a proper standard of service to your clients;
- 6. behave in a way that maintains the trust the public places in you and in the provision of legal services;
- 7. comply with your legal and regulatory obligations and deal with your regulators and ombudsmen in an open, timely and co-operative manner;
- 8. run your business or carry out your role in the business effectively and in accordance with proper governance and sound financial and risk management principles;
- 9. run your business or carry out your role in the business in a way that encourages equality of opportunity and respect for diversity; and
- 10. protect client money and assets.

SUCESSFUL TRAINING ATTITUDE



DOS

- 1. Attention to detail.
- 2. Taking time in doing tasks.
- 3. Treating the supervisor as the client.
- 4. Asking a lot of questions / understand what is being asked of you.
- 5. Making mistakes is fine / don't repeat it
- 6. Wanting to learn and get involved.
- 7. Do what you are asked never think you know better than your supervisor
- 8. Except where you train at a family firm, respect the fact that getting a training contract is hard



DON'TS

- 1. Expect 9 -5 job (if that's what you want, law is not really the field for you).
- 2. Expect intellectually challenging work.
- 3. Expect to give client advice.
- 4. Expect your clients to be angels.
- 5. Expect all lawyers the same find your self.
- 6. Don't argue with your supervisor ever do what you are asked.
- 7. Don't expect that you will make a major mistake and the supervisor will have a quite word with you with a smile
- 8. Don't do free hand drafting start with a precedent
